### CLUB VICTORY MEMBERSHIP AND PROMOTION TERMS AND CONDITIONS

The completed Club Victory application form (Form) and these terms (including any incorporated terms) form a binding and enforceable legal agreement (Agreement) between the person(s) or entity named on the Form (you, your or Club Victory member) and Melbourne Victory Limited ACN 111 441 868 trading as the Melbourne Victory Football Club (Club, MV, we or us).

- By applying for or otherwise accepting membership of the Club Victory program, You agree to be bound by and comply with these terms.
- Nothing in these terms excludes, restricts or modifies any consumer guarantee, right or remedy conferred on you by the Australian Consumer Law in Schedule 2 of the Competition and Consumer Act 2010 (Cth) or any other applicable law that cannot be excluded, restricted or modified by agreement (Non-Excludable Rights).

## Applying for and obtaining Club Victory membership

- 3. Payment of membership must be made at the time of receipt of the Form by the Club. Unless and until payment has been made, the Rebate Program (means the program set out in items 13 to 18 (inclusive)) and Club Victory Benefits (as described for each category of Club Victory Membership set out, or referred to, in items 9 to 12 (inclusive)) will not apply to You.

# **Club Victory Benefits**

- 9. Club Victory Renewing Clubs: All Club Victory Renewing Clubs (being clubs that were part of the Club Victory program for A-Leagues season 2022/23) will receive:
  - (a) Entry into the Registration Promotion;
  - (b) Entry into the Renewing Clubs Promotion;
  - (c) Participation in the Rebate Program;
  - (d) 6 x opportunities to have 1 x player appearance at your club at such a time, date and location as approved by the Club (acting reasonably, and provided the appearance is no more than 90 mins in duration);

- Club Victory Partners: All Club Victory Match Day Partners (being any Club Victory Member that was not a member of Club Victory for the 2022/23 A-Leagues season) will receive:
  - (a) Entry into the Registration Promotion;
  - (b) Participation in the Rebate Program;
  - (c) Entry into the existing members promotion;
- 11. The Club, reserves the right to, acting reasonably and subject to any applicable laws, vary or remove membership benefits if existing membership benefits cannot be provided due to a Force Majeure Event (being any event or circumstance or combination of events or circumstances which is beyond the reasonable control of a party, including an act of God, fire, lightning, explosion, flood, subsidence, insurrection, epidemic, pandemic or civil disorder or military operations), including any COVID-19 event. ## **Rebate Program**

- 13.   - (b) Any ticketing offers which the Club determines, in its discretion, to provide to you in order to try and maximise the number of New CV Affiliated Members.
- 15. In consideration of MV providing the items set out in item 14 to you, you must ensure that you (ie the relevant Club Victory member):
  - (a) Promotes the Club and its membership program using the Relevant Content; and
  - (b) Uses all reasonable endeavours to maximise the number of New CV Affiliated Members.
- 16. In order for MV to determine the amount of the Rebate, the relevant Club Victory Member must provide MV within 10 Business Days of being requested to do so, with (Requested Information):
  - (a) A list of all New CV Affiliated Members (in the format requested by MV); and
  - (b) All other information reasonably required in order for MV to calculate the Rebate.

(including loss of opportunity); whether direct, indirect, special or consequential, arising in any way

out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third-party interference; (c) any entry that is late, lost, altered, damaged or misdirected (whether or not

after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.

### Privacy General

- The Club may choose not to enforce a term of this Agreement in some cases in its absolute discretion without affecting its right to enforce that term in other cases.
- 52. These terms:
  - (a) are governed by the law applicable in the state of Victoria and each party submits to the jurisdiction of the courts of that State; and
  - (b) are the entire agreement between the Club and you in respect of its subject matter and to the extent permitted by law, supersedes any prior agreement, representation or promotional material.
- 53. Neither party shall be liable for any delay or failure to perform its obligations under these terms, other than payment of any monetary sums due and owing to the other party, if such failure or delay is due to a Force Majeure Event.
